Instructions for Completing the Application for Advanced Standing Full-Time and Part-Time MBA Students

New Students

A student may receive <u>a maximum of 6 credits</u> of advanced standing: the total of graduate transfer credits (Department Chair approval may be needed), credit if you have a CPA, credit from a JD degre, and/or completion of a mini-MBA.

Please note: No transfer credit can be awarded for any courses taken more than five years before the time of initial enrollment in the MBA program.

- You may only request advanced standing within the <u>first semester</u> upon entering the MBA program. If a student does not submit a request for advanced standing by the end of the first semester, they forfeit the opportunity to receive advanced standing for courses taken prior to enrolling in the Rutgers MBA program.
- You may only receive elective credit from courses taken at another AACSB accredited MBA program for which you did not complete the degree (Subject to the Department Chair's approval of course content). There is a 5 year time limit and the grade of the course must be a 'B' or better.
- You may include the course description.
- Students may be waived out of the Accounting for Managers course if they have a CPA license and earn 3 credits.
- Students may be waived out of the Law & legal Reasoning course if they have a JD degree and earn 2 credits.
- Students may earn 3 elective credits if they have completed a Rutgers mini-MBA certificate and passed the final exam.
- Submit the Application for Advanced Standing Credit to the Admissions Office via fax or email.
